PRO - Ben Glass

JUDGES (so far) - Jared Hickman, Dick Rose - They are organizing a team of judges. Plan is to have three judge boats with two judges each.

HOTEL ROOMS are being blocked at two places. Hotel Bellwether (\$169) and Best Western (\$89) Bellwether is right by the yacht club and a good view of the racing area.

FLIGHTS - West Coast sailors should check into Allegiant Air flights direct to Bellingham. There are also Alaska flights direct and if the price is within \$40 of the Allegiant flight it is worth spending more for Alaska Airlines. Non-west coast sailors can either fly into Seattle and then take a puddle jumper to Bellingham or rent a car in Seattle and drive the 2 hour drive north.

DAYS - I have set the NOR with a three day event so far, but I will change to a two day event if that gets decided. My opinion is to stay with a three day event as wind is unreliable, especially in the NW, and having 3 days gives more opportunity to have quality races.

1. RULES

Notice of Race

- 1.1 The regatta will be governed by the rules as defined in the Racing Rules of Sailing (RRS) 2013-2016, the Prescriptions of US Sailing, the Inter-Collegiate Sailing Association (ICSA) Procedural Rules (PR), the General Conditions for ICSA National Championships, Conditions for Singlehanded Nationals, this Notice of Race and the Sailing Instructions. The Organizing Authority is the ICSA. All questions of rule interpretation or procedure shall be addressed in writing to the ICSA Representative before or at the regatta. Answers to such questions will be posted on the Official Regatta Notice Board.
- 1.2 ICSA PR 32 will be in effect

2. ELIGIBILITY

- 2.1 Only ICSA Pre-Qualified Sailors are eligible to compete. Selection of competing sailors for these championships will be by Conference Elimination. The ICSA will publish a list of sailors selected to compete in the championships.

3. REGISTRATION AND ENTRY FEE

- 3.1 The Entry Fee is \$100 per competitor payable during online registration via credit card. The entry form and all registration materials will be available online at: collegesailing.org
- 3.2 A fully completed "Conditions of Charter" agreement must be on file with the Laser Performance Representative before receiving a charter boat. This form includes the requirement of a valid credit card that can be used to pay for damage. This form also requires the signature of a parent or guardian for anyone under 18 years of age.
- 3.3 The entry deadline is October 27, 2014.

- 4.1 Laser Performance will supply Laser Sailboats to the Men and Laser Radial Sailboats to the women. Sails are also provided. Competitors may provide and use temporary telltales, wind indicators and personal tillers and extensions. There will be no rotation of boats. Men will compete in Full-Rigged Lasers for the Glen S. Foster Trophy, and the Women will compete in Laser Radials for the Janet Lutz Trophy.

The Women's Champion will have her name and college engraved on the Janet Lutz Trophy. ICSA will provide keeper trophies for the top three finishers in each fleet.

13. PHOTOGRAPHY CONSENT

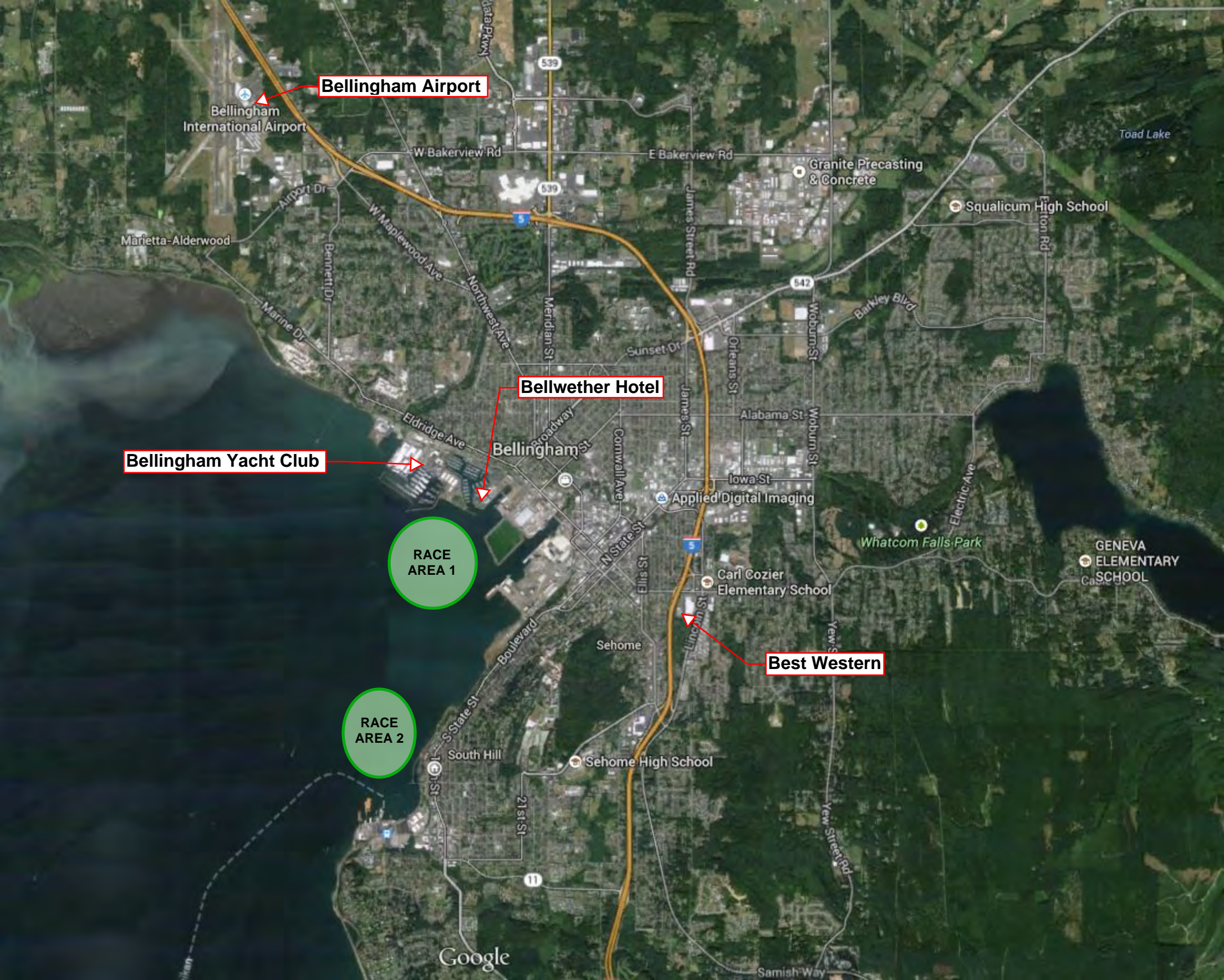
