Investment Account

The investment account with Wells Fargo has done poorly for 2015 as it is closely tied with the stock market. We also withdrew \$12,000 in February to help to fund the expense of the production of the new website.

We are fortunate to have continued financial support from our sponsors. The full details are outlined in the financial statement. It appears that there will be some shift in sponsors in 2016 as some will not renew and some new sponsors are under contract.

Operating Expenses

Development funds were used to continue with the upgrades to the scoring program as well as a large expenditure on the production of the new website.
