- B. (SAISA) Any dinghy sailing event which is held on the same competition weekend at the same venue must be considered one single event, and may not be separated into two events or graded separately unless there is:
  - a separation of competitors based on the results of the first event (i.e. one regatta results determine placement into the second event's "championship" and "consolation" brackets);
  - 2. or a change of discipline or classification (i.e. one event fleet racing, one event team racing; one event open, one event women's).
  - 3. a significant change in the register of teams participating (more than half teams participating in event one different than those participating in event two)
  - 4. This rule would be relevant for both fleet race and team race events and would go into effect at the start of the Fall 2024 season and effective thereafter.
