

Nominating Committee Final Report

Following the 2021 ICSA Winter meeting, Mitch Brindley assigned Ali Blumenthal, Dillon Paiva, Blaine Pedlow and Adam Werblow to work with Preston Anderson, the ICSA Vice President, on developing a slate of nominations for the 2021 ICSA Annual Meeting. During the initial meetings, the committee designated which boards and committees were the most important to fulfill the diversity portfolio set by ICSA bylaw article VII. After careful consideration we decided that the Board of Directors, Championships and Competition Committee, Eligibility Committee, Communications Committee and the All- Academic Committee were the most important to focus our attention on. We then solicited nominations from all of the conference commissioners. Once we received all of the nominations we carefully and thoughtfully deliberated on all of the nominees and wanted to make sure that we were selecting the best candidates for each role within the ICSA. For the additional undergrad to the Board of Directors. we interviewed each of the nominees and then held a vote on who we thought would be the best representative for the Board of Directors. All nominees were phenomenal and unfortunately we are only able to nominate one undergrad for the role. In the end, the committee selected Julia Reynolds from Brown to serve as the additional undergraduate representative on the ICSA Board of Directors.

We experienced many successes with the nomination process this year. Nearly all of the conferences had phenomenal nominees and made the Nominating Committee's job a lot easier since we had a large pool of candidates to choose from. In addition, the fact that undergrads stepped up and wanted to take part in the governance of College Sailing should not be lost and shows that the undergraduate voice is an important one to our sport. Finally, considering that we are still in a pandemic but were able to get a slate of nominations for the ICSA demonstrates the growing interest in our sport and hopefully as the pandemic comes to an end we see a continuation of that excitement.

The Nominating Committee didn't experience many challenges this year. However, finding club sports administrators will always be a difficult task. If we are able to find a club sports admin who is interested, we should and will find some way to get them involved with the governance of our sport. College Sailing is a big family as we have varsity and club teams that compete against each other. It is important that every voice is heard and we are making decisions that will benefit all of our member teams and not only a small group.

In order to retain institutional knowledge, we strongly encouraged all of our new at large committee nominees to stay on longer than their one year term. We also encourage any

outgoing committee members, especially committee chairs, to engage in a turnover process with their replacements. This can be as simple as a phone call.

The Nominating Committee would like to suggest that the Executive Committee reform the adhoc Membership and Development Committee. When schools reform in the fall of 2021, there will be many teams that will struggle to return to their established positions within their schools. These schools could benefit from the assistance and any institutional knowledge the ICSA can pass down.

While going through this process of filling out the ICSA leadership portfolio on our standing committees, the Nominating Committee found a few areas where the ICSA Bylaws could be clarified. We will draft a small set of changes that will help clarify the role of the Nominating committee, and the process of conferences nominating representatives to committees. This will be circulated and presented prior to the 2022 ICSA Winter Meeting.

Finally, the Nominating Committee would like to thank Danielle Richards for her years of service as the ICSA Secretary. We look forward to Danielle continuing to lend her expertise as an at-large representative on the ICSA Executive Committee.
