Amendment #1 to Notice of Race

The following changes are being made to the Notice of Race for the 2022 ICSA Match Race Nationals being hosted by San Diego Yacht Club on November 11-13, 2022:

1. **NOR 7 "Rules"** is changed by adding the following **NOR 7.13** regarding the "Exclusion Zone" following NOR 7.12, said **NOR 7.13** shall read as follows:

7.13 ICSA Championship Committee has decided that the "Exclusion Zone" provided for in ICSA Procedural Rule 27. Practice Prior to an ICSA National Championship "**shall be the waterways of San Diego County. This includes Mission Bay, and San Diego Bay.**"

(The purpose of this change is to notify competitors of the ICSA "Exclusion Zone" per ICSA Procedural Rule 27.)

2. **NOR 11 "Communication"** is deleted in its entirety and replaced with the below new **NOR 11.1** and **11.2** which shall read as follows:

11. COMMUNICATION

11.1 Notices to competitors prior to the event will be posted on the online notice board which is located at <https://2022matchrace.collegesailing.org>
During the event, Notice to competitors and amendments to the NOR or SIs will be posted on the SDYC notice board on the east side of the Malin Burnham Sailing Center.

11.2 Each team shall supply their own **VHF radio** for broadcasts from the RC. Broadcasts will be made on a channel set forth in the Sailing Instructions.

*(The purpose of this change is to inform competitors that during the event notices will be posted on the **SDYC notice board**, in addition competitors are informed that they will need to bring a **VHF radio** to hear broadcasts from the RC during the event)*

3. **NOR 19 “Additional Information”** is deleted in its entirety and replaced with the below new **NOR 19** which shall read as follows:
